DURING THE TWELVE MONTHS ENDED JUNE 30, 2018, CHT PROVIDED SHELTER AND SERVICES TO 320 YOUTH FOR 14,362 DAYS OF SERVICE. THE CLINIC IS STAFFED BY LICENSED NURSES AND RESIDENTS SUPERVISED BY A PHYSICIAN FROM BAYLOR COLLEGE OF MEDICINE. IN ADDITION TO TREATMENT OF ILLNESSES AND MINOR INJURIES, SERVICES ALSO INCLUDE: SEXUALLY TRANSMITTED DISEASE DETECTION, TREATMENT AND PREVENTION; HIV TESTING, COUNSELING AND REFERRAL INFORMATION; IMMUNIZATION; MENTAL HEALTH AND SUBSTANCE ABUSE COUNSELING AND REFERRAL; REFERRAL FOR DENTAL AND EYE CARE. DURING THE YEAR ENDED JUNE 30, 2018, CHT PROVIDED 2,570 CLINIC VISITS AND 615 HEALTH ASSESSMENTS AND/OR INTERVENTIONS.
